ПЕРЕДМОВА

Важливий та відповідальний напрям діяльності Наукової бібліотеки Національного юридичного університету імені Ярослава Мудрого (НЮУ ім. Ярослава Мудрого) – це робота з бібліометричної підтримки публікаційної активності науково-педагогічних працівників. У структурі бібліотеки створена спеціальна Служба бібліометрії та наукометрії, яка є секторальним осередком інформаційно-бібліографічного відділу, що виконує завдання з консолідації процесів моніторингу, обліку, систематизації, аналізу та оприлюднення бібліометричних, наукометричних показників учених ЗВО щодо публікаційної активності в міжнародних наукометричних базах Scopus та Web of Science.

Бібліографічний дайджест «Публікації науковців Національного юридичного університету імені Ярослава Мудрого, проіндексовані в міжнародних наукометричних базах Scopus та Web of Science у 2023 році» підготовлено з метою реалізації бібліотекою сучасних вимог до інформаційно-бібліографічного забезпечення розвитку й відкритості наукових досліджень з питань правознавства.

Джерелознавчу базу видання склали: бібліографічна і реферативна база даних Scopus (видавництво Elsevier); бази Core Collection, Medline, BIOSIS платформи Web of Science; веб сайти наукових видань, в яких опубліковані наукові статті.

Загальний обсяг дайджесту представлений науковими публікаціями учених Університету, які були проіндексовані протягом 2023 року в Scopus та Web of Science. Бібліографічний опис документів здійснено відповідно ДСТУ 8302:2015 «Бібліографічне посилання. Загальні положення та правила складання». Надаються відомості про наявність цифрового ідентифікатора (DOI) або посилання на електронну версію статті. Усі публікації опрацьовані de visu. Астериском (*) позначені науковці, які працювали в НЮУ ім. Ярослава Мудрого до 2024 року.

Матеріали основної частини дайджесту структуровано за розділами: "Scopus" (включає окремі підрозділи для публікацій не в профілі Університету та переіндексованих

публікацій; загалом 169 публікацій), "Web of Science" (включає окрім підроздили для публікацій не в профілі Університету: базах Medline, BIOSIS та публікацій, які мають афіляцію іншої організації; загалом 84 публікації), "Одночасна індексація публікацій у Scopus та Web of Science" (загалом 39 публікацій). У рамках розділів/підрозділів публікацій систематизовано в алфавітному порядку авторів.

Довідковий апарат складається зі змісту, передмови, алфавітного покажчика авторів Університету.

Бібліографічний дайджест висвітлює пріоритетні напрями наукових досліджень НЮУ ім. Ярослава Мудрого, надає систематизовану бібліометричну інформацію щодо індексації/переіндексації статей і призначений науковцям, викладачам, докторантам, аспірантам, студентам юридичних закладів вищої освіти, а також усім, хто цікавиться проблемами відкритої правничої науки.
